1. Call to Order/Introductions/Review Agenda -

On a motion Al Willstatter, seconded by Kay Harrison, the Council unanimously elected Mike Stitt as 2015 Vice Chairman.

Subsequent to the voice vote, the nominations were closed. The motion passed unanimously by voice vote.

5. RVMPO PAC Member Applications –

- Edgar Hee submitted a new member application to represent Bike/Ped.

Ron Holthusen made a motion, seconded by Mary Wooding, to submit the seven (7) PAC applications, and two (2) new members to the Policy Committee with an affirmative recommendation for appointment. The motion passed unanimously by voice vote.

6. RVMPO Public Advisory Council Bylaws Update –

Dan Moore presented the proposed Bike/Ped amendment to the Council. The Policy Committee decided to leave the formulaic representative as it is currently configured, and adopted the Bylaws amendment. Brad Inman clarified that Medford still had six (6) representatives, three (3) from East Medford, and three (3) from West Medford.

7. MPO Planning -

- Jonathan David is on medical leave until the end of February. Glen Anderson shared that this would probably be his final term on the Council.
- DLCD & ODOT are working on the Strategic Assessment on greenhouse gasses.
- 2010 benchmark analysis for alternative transportation measures are updated, and will go to the TAC in February. It will come to the PAC at a later date.
- The work Program for the next fiscal year will come to the PAC in March.
- Mike Montero suggested scheduling a meeting to discuss the Alternative Measures in more detail. He also gave a brief overview of urban growth boundary expansions as they relate to transportation and the need for affected cities to be careful in their future policy decisions about capacity expansions. Al Willstatter spoke about transportation funding limitations. Mike Montero also mentioned greenhouse gasses and alternative fuel measures. Kay Harrison asked that the PAC be updated on potential transportation legislation at the State level at a future meeting. Council members discussed compressed

and methane gas as a fuel source. The PAC does not have a current position on the natural gas pipeline.

8. Other Business -

Dan Moore shared that the Grants Pass-Medford commuter line is going to do an "on board" survey in the next few months.

9. Public Comment -

There were no public comments.

10. Next Meeting

The next meeting is scheduled for March 17, 2015, in the RVCOG conference room, at 5:30 PM. Chairman Prunty will not be at this meeting.
